### **NOTICE OF FILING AND REQUEST FOR COMMENTS**

D.P.U. 24-PGAF-BERK

September 9, 2024

Petition of The Berkshire Gas Company pursuant to G.L. c. 164 and 220 CMR 6.04, 6.11 for approval of its 2024/25 local distribution adjustment factor and peak gas adjustment factor filings, effective November 1, 2024.

On August 14, 2024, The Berkshire Gas Company ("Company") filed with the Department of Public Utilities ("Department") its seasonal local distribution adjustment factor filing ("LDAF"), pursuant to G.L. c. 164 and 220 CMR 6.11. The filing includes the residential assistance adjustment factor ("RAAF"), remediation adjustment factor ("RAF"), Attorney General consultant expense factor ("AGCEF"), energy efficiency surcharge ("EES"), and pension adjustment factor ("PAF"). The proposed rates are for effect November 1, 2024. The Department has docketed this petition as D.P.U. 24-PGAF-BERK.

The table below summarizes the proposed rates in dollars per therm: 1

Rate Class	<b>LDAF</b>
Residential	\$0.3122
Small C&I	\$0.1463
Medium C&I	\$0.1360
Large C&I	\$0.1175
X-Large C&I	\$0.0106

If the Department approves the Company's LDAFs as proposed, a typical residential heating customer will see an **average monthly bill decrease of \$6.41 or 2.6 percent** in the winter, compared to the LDAF currently in effect. For specific bill impacts, please contact the Company as shown below.

The Company is required to file its peak gas adjustment factor filing ("GAF") filing in this docket no later than September 17, 2024, at least 45 days prior to the date on which the proposed GAFs are to be effective (November 1, 2024). The Company may, at any time during

For presentation purposes, the Company has included the Peak Revenue Decoupling Adjustment Factor ("RDAF") in the proposed LDAF for each rate class. The Company's current RDAFs are \$0.0443, \$0.0259, \$0.0266, \$0.0236, and \$0.000, respectively, for the residential, small commercial and industrial ("C&I"), medium C&I, large C&I, and extra-large C&I rate classes.

the peak period, submit an amended GAF filing. The amended GAF filing must be submitted seven business days before the first billing cycle of the month in which it is proposed to take effect.

Any person interested in commenting on the LDAF filing may submit written comments no later than the close of business (5:00 p.m.) on Friday, October 4, 2024. Any person interested in commenting on the GAF filing may submit written comments no later than the close of business on Friday, October 11, 2024.
