NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 23-GREC-02

Petition of The Berkshire Gas Company, pursuant to G.L. c. 164, § 145, for Review and Approval of the Reconciliation of its 2022 Gas System Enhancement Plan and Gas System Enhancement Reconciliation Adjustment Factors.

On May 1, 2023, The Berkshire Gas Company ("Berkshire" or "Company") submitted to the Department of Public Utilities ("Department") a reconciliation of its 2022 gas system enhancement plan ("GSEP") to replace aging natural gas pipeline infrastructure. Based on the Company's calculations, Berkshire proposes to refund \$44,291 to ratepayers as over-recoveries through the gas system enhancement reconciliation adjustment factors ("GSERAFs") for the period from November 1, 2023 to October 31, 2024. The Company states that its proposed revenue requirement does not exceed the three-percent GSEP cap. The Department has docketed this matter as D.P.U. 23-GREC-02.

The Company proposes the following GSERAFs by rate class sector for effect November 1, 2023:

Rate Class Sector	Proposed GSERAF (\$/Therm)
Residential (R-1 to R-4)	\$(0.0007)
Small Commercial and Industrial (C&I) (G-41/G-51)	\$(0.0006)
Medium Annual Use C&I (G-42/G-52)	\$(0.0004)
Large Annual Use C&I (G-43/G-53)	\$(0.0002)
Extra Large Annual Use C&I (T-54)	\$(0.0000)

The Company states that approval of the GSERAFs will result in an average monthly bill decrease of \$0.19, or 0.07 percent, for the average residential heating customer using 136 therms per month during the winter months, and an average monthly bill decrease of \$0.04, or

0.08 percent, for the average residential heating customer using 29 therms per month during the summer months.

The Department is providing a written comment period and any person interested in commenting on this matter may submit written comments no later than the close of business (5:00 p.m.) on Friday, June 16, 2023. Written comments from the public may be sent by email to dpu.efiling@mass.gov, alice.davey@mass.gov, and the Company's attorney, Brendan Vaughan, at bvaughan@keeganwerlin.com. The Department strongly encourages public comments to be submitted by email. If, however, a member of the public is unable to send written comments by email, a paper copy may be sent to Mark D. Marini, Secretary, Department of Public Utilities, One South Station, 5th Floor, Boston, Massachusetts, 02110.

Any person who desires to participate in the evidentiary phase of this proceeding must file a written petition for leave to intervene with the Department not later than the close of business (5:00 p.m.) on Friday, May 27, 2023. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. All petitions for leave to intervene must be submitted by email only to dpu.efiling@mass.gov, alice davey@mass.gov, and the Company's attorney at bvaughan@keeganwerlin.com. Receipt by the Department, not mailing, constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by email by the close of business (5:00 p.m.) on the second business day after the petition to intervene was filed. The Attorney General of the Commonwealth of Massachusetts filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E(a).

Documents provided to the Department must specify: (1) the docket number of the proceeding (D.P.U. 23-GREC-02); (2) the name of the person or company submitting the filing; (3) a brief descriptive title of the document; and (4) the name, title, email address, and telephone number of a person to contact in the event of questions about the filing.
