NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 24-125

October 1, 2024

Petition of The Berkshire Gas Company for approval of its annual pension adjustment factor rate adjustment and reconciliation filing for effect November 1, 2024.

On August 9, 2024, The Berkshire Gas Company ("Company") filed its annual pension and post-retirement benefits other than pensions factor ("PAF") rate adjustment and reconciliation filing with the Department of Public Utilities ("Department") for effect November 1, 2024. On September 25, 2024, the Company filed a revised PAF filing. The Department docketed this matter as D.P.U. 24-125.

The PAF is a component of the Company's Local Distribution Adjustment Factor ("LDAF"), pursuant to its Local Distribution Adjustment Clause tariff, M.D.P.U. No. 583. The Company's proposed LDAF for effect November 1, 2024, is currently under review in <u>The</u> <u>Berkshire Gas Company</u>, D.P.U. 24-PGAF-BERK.

The Company proposes the following PAFs for effect November 1, 2024:

Through its PAFs, the Company proposes to credit customers \$368,089. If the Department approves the Company's revised PAFs as proposed, the Company states that customers will experience the following bill impacts:

• an average residential heating customer (R-3) using 136 therms per month during the peak period (<u>i.e.</u>, November 1, 2024 through April 30, 2025) will experience an average monthly bill decrease of \$1.30, or 0.52 percent;

- an average residential heating customer (R-3) using 29 therms per month during the off-peak period (<u>i.e.</u>, May 1, 2025 through October 31, 2025) will experience a monthly bill decrease of \$0.00, or 0.00 percent;
- an average residential non-heating customer (R-1) using 18 therms per month during the peak period (<u>i.e.</u>, November 1, 2024 through April 30, 2025) will experience an average monthly bill decrease of \$0.17 or 0.32 percent;
- an average residential non-heating customer (R-1) using 11 therms per month during the off-peak period (<u>i.e.</u>, May 1, 2025 through October 31, 2025) will experience an average monthly bill decrease of \$0.00, or 0.00 percent;
- an average low-income heating customer (R-4) using 123 therms per month during the peak period (<u>i.e.</u>, November 1, 2024 through April 30, 2025) will experience an average monthly bill decrease of \$0.88, or 0.52 percent;
- an average low-income heating customer (R-4) using 26 therms per month during the off-peak period (<u>i.e.</u>, May 1, 2025 through October 31, 2025) will experience an average monthly bill decrease of \$0.00, or 0.00 percent;
- an average low-income non-heating customer (R-2) using 20 therms a month during the peak period (<u>i.e.</u>, November 1, 2024 through April 30, 2025) will experience an average monthly bill decrease of \$0.14, or 0.33 percent; and
- an average low-income non-heating customer (R-2) using 11 therms a month during the off-peak period (<u>i.e.</u>, May 1, 2025 through October 31, 2025) will experience an average monthly bill decrease of \$0.00, or 0.00 percent.
- C&I bill impacts will vary. For specific bill impacts, these customers should contact the Company as shown below.

The Company has proposed other changes to its rates effective November 1, 2024 in D.P.U. 24-PGAF-BERK which will also have an impact on customers' bills.

Any person who desires to participate otherwise in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on **Tuesday**, **October 15, 2024.** A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on the <u>second</u> business day after the petition to intervene was filed.

To the extent a person or entity wishes to submit comments or a petition to intervene in accordance with this Notice, electronic submission is sufficient. All documents should be submitted to the Department in **.pdf format** by email attachment to <u>dpu.efiling@mass.gov</u> and <u>katherine.e.stock@mass.gov</u>. In addition, one copy of all written comments and petitions to intervene should be emailed to the Company's attorney, Brendan Vaughan, Esq. at <u>bvaughan@keeganwerlin.com</u>. The text of the email must specify: (1) the docket number of the proceeding (D.P.U. 24-125); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document.
