NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 24-GSEP-02 November 12, 2024

Petition of The Berkshire Gas Company for Approval of its 2025 Gas System Enhancement Plan, pursuant to G.L. c. 164, § 145, for rates effective May 1, 2025.

On October 31, 2024, The Berkshire Gas Company ("Berkshire" or "Company") submitted to the Department of Public Utilities ("Department") its 2025 gas system enhancement plan ("GSEP") to replace aging natural gas pipeline infrastructure. Berkshire states that its 2025 revenue requirement is \$7,513,652, which represents the cumulative cost to replace eligible leak-prone infrastructure through the end of calendar year 2025. The Company proposes to collect this amount through the gas system enhancement adjustment factors ("GSEAFs"). The Company states that its proposed revenue requirement exceeds the three-percent cap. The Company is requesting a waiver from the three-percent cap. The Department docketed this matter as D.P.U. 24-GSEP-02.

According to the Company, its proposed 2024 GSEP is consistent with the requirements of G.L. c. 164, § 145, which allows gas distribution companies to accelerate the replacement of eligible infrastructure to improve public safety or infrastructure reliability, and to reduce or potentially reduce lost and unaccounted for natural gas.

The Company states that approval of the GSEAFs will result in a monthly bill increase of \$7.08 or 2.88 percent for the average residential heating customer using 136 therms per month during the winter months, and a monthly bill increase of \$1.52 or 3.64 percent for the average residential heating customer using 29 therms per month during the summer months. Pursuant to G.L. c. 164, § 145, on May 1, 2026, the Company will submit to the Department the amount recovered through the GSEAFs for reconciliation with actual 2025 calendar year GSEP costs.

The Company proposes the following GSEAFs by rate class sector for effect May 1, 2025:

Any person who desires to participate otherwise in the evidentiary phase of this proceeding shall file a petition for leave to intervene no later than 5:00 p.m. on **Wednesday**, **November 20, 2024**. A petition for leave to intervene must satisfy the timing and substantive requirements of 220 CMR 1.03. Receipt by the Department constitutes filing and determines whether a petition has been timely filed. A petition filed late may be disallowed as untimely, unless good cause is shown for waiver under 220 CMR 1.01(4). To be allowed, a petition under 220 CMR 1.03(1) must satisfy the standing requirements of G.L. c. 30A, § 10. All responses to petitions to intervene must be filed by the close of business (5:00 p.m.) on the <u>second</u> business day after the petition to intervene was filed.

The Attorney General of the Commonwealth of Massachusetts ("Attorney General") filed a notice to intervene in this matter pursuant to G.L. c. 12, § 11E. Further, pursuant to G.L. c. 12, § 11E(b), the Attorney General filed a notice of intent to retain experts and consultants to assist her investigation of the Company's filing and has requested Department approval to spend up to \$150,000 in this regard. Pursuant to G.L. c. 12, § 11E(b), the costs incurred by the Attorney General relative to her retention of experts and consultants may be

recovered in the Company's rates. Any person who desires to comment on the Attorney General's notice of intent to retain experts and consultants may submit written comments to the Department not later than the close of business (5:00 p.m.) on **Wednesday**, **November 20, 2024**.

The text of the email must specify: (1) the docket number of the proceeding (D.P.U. 24-GSEP-02); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document.
