NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 23-74

August 17, 2023

Petition of The Berkshire Gas Company for approval of its Revenue Decoupling Adjustment Factors for the 2023 Peak Period, November 1, 2023, through April 30, 2024.

On August 3, 2023, The Berkshire Gas Company ("Company") filed a petition with the Department of Public Utilities ("Department") for approval of its revenue decoupling adjustment factors ("RDAFs"), for effect November 1, 2023. This filing was made pursuant to <u>The</u> <u>Berkshire Gas Company</u>, D.P.U. 22-20 (2022), <u>The Berkshire Gas Company</u>, D.P.U. 18-40 (2019), and the Company's revenue decoupling adjustment clause ("RDAC") tariff, M.D.P.U. No. 579. In 2008, the Department developed revenue decoupling by establishing a mechanism through the RDAC that allows the Company to modify, on a semi-annual basis, its base distribution rates as a result of changes in customer usage. Revenue decoupling severs the link between sales and revenues, and instead provides gas and electric utility companies with a target revenue level, thus removing the disincentive of implementation of energy efficiency and demand reduction programs that encourage customers to lower energy usage and demand. <u>See generally Revenue Decoupling</u>, D.P.U. 07-50-A (2008); <u>see also NSTAR Gas Company</u>, D.P.U. 23-74.

The Company proposes the following charges effective November 1, 2023, through April 30, 2024:

Customer Rate Classes	RDAF charges (\$ per therm)
Residential	0.0524
Small Commercial and Industrial ("C&I")	0.0439
Medium C&I	0.0265
Large C&I	0.0235

As a result of the proposed changes to the RDAF, the average residential heating customer (customer class R-3) using on average 136 therms per month during the peak period will experience a bill increase of \$8.08 or 3.01 percent from the previously effective peak period RDAF. The Company states that the average monthly bill impact for all rate classes at each class's average use during the peak period will range from increases of between 1.88 percent to 3.01 percent as compared to the previously effective peak period RDAF.
