NOTICE OF FILING AND REQUEST FOR COMMENTS

D.P.U. 22-PGAF-BERK

August 17, 2022

Petition of The Berkshire Gas Company pursuant to G.L. c. 164 and 220 CMR 6.04, 6.11 for approval of its 2022/23 local distribution adjustment factor and peak gas adjustment factor filings, effective November 1, 2022.

On August 8, 2022, The Berkshire Gas Company ("Company") filed with the Department of Public Utilities ("Department") its seasonal local distribution adjustment factor filing ("LDAF"), pursuant to G.L. c. 164 and 220 CMR 6.11. The filing includes the residential assistance adjustment factor ("RAAF"), remediation adjustment factor ("RAF"), attorney general consultant expense factor ("AGCEF"), energy efficiency surcharge ("EES"), and pension adjustment factor ("PAF"). The proposed rates are for effect November 1, 2022. The Department has docketed this petition as D.P.U. 22-PGAF-BERK.

The table below summarizes the proposed rates in dollars per therm:

Rate Class	LDAF
Residential	\$0.3196
Small C&I	\$0.1417
Medium C&I	\$0.1169
Large C&I	\$0.0952
X-Large C&I	\$0.0287

If the Department approves the Company's LDAFs as proposed, a typical residential heating customer will see an **average monthly bill decrease of \$12.65 or 5.10 percent**, compared to the LDAF currently in effect. For specific bill impacts, please contact the Company as shown below.

The Company will file its peak gas adjustment factor filing ("GAF") in this docket at least 45 days prior to the date on which the proposed GAFs are to be effective. The Company is required to file its peak GAF filing no later than September 16, 2022. The Company may, at any time during the peak period, submit an amended GAF filing. The amended GAF filing must be submitted seven business days before the first billing cycle of the month in which it is proposed to take effect.

Any person interested in commenting on the **LDAF** filing may submit written comments no later than the close of business (5:00 p.m.) on **September 16, 2022**. Any person interested in commenting on the **GAF** filing may submit written comments no later than the close of business

on **Friday, September 30, 2022**. At this time, all filings will be submitted only in electronic format consistent with the Commission's June 15, 2021 directive related to modified filing requirements. Ordinarily, all parties would follow Sections B.1 and B.4 of the Department's Standard Ground Rules (D.P.U. 15-184-A, App. 1 (March 4, 2020)); however, until further notice, parties must retain the original paper version and the Department will later determine when the paper version must be filed with the Department Secretary.

All written comments or other documents should be submitted to the Department in **.pdf format** by e-mail attachment to <u>dpu.efiling@mass.gov</u> and the hearing officer, Christine Dowling at <u>christine.dowling2@mass.gov</u>. In addition, all written comments should be emailed to the Company's attorneys, Brendan Vaughan, Esq., at <u>bvaughan@keeganwerlin.com</u>, and Leonard Rodriguez, Esq., at <u>Leonard.Rodriguez@avangrid.com</u>. The text of the e-mail must specify: (1) the docket number of the proceeding (D.P.U. 22-PGAF-BERK); (2) the name of the person or company submitting the filing; and (3) a brief descriptive title of the document. The electronic file name should identify the document but should not exceed 50 characters in length. Importantly, all large files submitted must be broken down into electronic files that <u>do not exceed 20 MB</u>.
